Healthier Home Initiative Addresses Philadelphia's Asthma Crisis Unique program shows how in-home interventions can improve asthma

Washington, DC – October 18, 2018 – The **asthma & allergy friendly®** Certification Program partnered with the Children's Hospital of Philadelphia to help 30 families in the region improve their indoor home environment.

"According to our annual Asthma Capitals research, Philadelphia is the fourth most challenging place in the country to live with asthma," states Asthma and Allergy Foundation of America (AAFA) CEO and president Kenneth Mendez. "Philadelphia is our #4 Asthma Capital due to its high asthma prevalence, air pollution, poverty and number of asthma fatalities."

The **asthma & allergy friendly®** Certification Program, administered by AAFA in partnership with Allergy Standards Limited (ASL), is an independent program created to scientifically test and identify consumer products that are suitable for making homes healthier. To raise awareness about the impact of asthma and the value of controlling the indoor environment, the program launched the Philadelphia Healthier Homes Initiative in collaboration with the Community Asthma Prevention Program at Children's Hospital of Philadelphia.
