Asthma and Allergy Foundation of America to Comment on the Recruitment of Ethnically Diverse Populations to Support Clinical Trials

The FDA's meeting will discuss progress in implementing their "Action Plan to Enhance the Collection and Availability of Demographic Subgroup Data"

**Washington, D.C.** (February 29, 2016) - The Asthma and Allergy Foundation (AAFA), America's leading advocacy organization for individuals living with asthma, food allergies and allergic disease, will provide public remarks at a meeting of the Food and Drug Administration (FDA) later today to ensure underserved and ethnically diverse patient populations have a voice in the development of new treatments through expanded inclusion in clinical trials.

AAFA's Senior Vice President of Policy, Advocacy and Research, Meryl Bloomrosen, MBI, MBA, shared, "The patient community needs increased research through clinical trials that is better, more effective, relevant and safe. The patient community also needs information that is communicated in ways that are more available, trustworthy, understandable and usable to support daily treatment. AAFA has the ability to support the FDA to build greater awareness, participation and engagement across the patient community, particularly those patients from diverse and underserved populations."

The public meeting, named "FDASIA Section 907: Inclusion of Demographic Subgroups in Clinical Trials," takes place between 9:00 a.m. and 4:00 p.m. at the FDA's White Oak Campus in Silver Spring, MD. Ms. Bloomrosen will speak at 3:00 p.m.
