Dear Leader Schumer, Speaker Pelosi, Leader McConnell, and Leader McCarthy:

We, the undersigned organizations representing patients, health care workers, children, older adults, people with disabilities, pregnant and postpartum women, and health insurance providers, are writing on behalf of the Modern Medicaid Alliance. We appreciate lawmakers' efforts to enhance reimbursements for home and community-based services, incentivize non-expansion states to expand Medicaid, and expand postpartum coverage in Medicaid, and we strongly encourage Congress to keep these provisions in the final legislation. Today we ask Congress with the greatest urgency to take the vital step of strengthening America's Medicaid program in upcoming COVID-19 relief legislation.

**We specifically call on Congress to enhance federal financing for Medicaid by increasing states' Federal Medical Assistance Percentage (FMAP) by a total of at least 12 percentage points, consistent with the previous request made by the bipartisan National Governors Association.**

As the number of Americans relying on Medicaid continues to [increase](#) due to the COVID-19 public health and economic crises, the Modern Medicaid Alliance is keenly focused on the challenges facing state Medicaid programs and the millions of Americans who rely on this critical safety net for essential health coverage. Medicaid is the largest health care program in the country, covering about 1 in 5 Americans, including millions of children, older adults, people with disabilities, and nearly 2 million veterans.

The number of Americans who rely on Medicaid and the Children's Health Insurance Program (CHIP) has grown dramatically during the COVID-19 crisis. From February to September 2020, Medicaid and CHIP enrollment has increased by more than [6 million](#) people, or 8.6% nationwide, with the [fastest enrollment growth](#) among non-elderly, nondisabled adults.



Through December 2022, an additional [5.03-10.25 million](#) people are projected to enroll in the Medicaid program as a result of the economic impact of COVID-19, reinforcing that now is the time to strengthen this vital program. Significant increased enrollment in the program is happening at the same time state revenues are dropping dramatically, and overall state budget shortfalls are [projected](#) to reach \$555 billion through 2022.

Without increased funding for Medicaid, hardworking Americans, many of whom are at an increased risk of severe impacts from COVID-19, could be denied access to the essential care they need and deserve. This is especially true for People of Color — who have been hardest hit by the crisis — with Medicaid providing coverage for more than [1 in 4](#) Black and Hispanic children and nonelderly adults. Absent increased funding, Medicaid enrollees stand to face [devastating consequences](#), such as:

- **Threatening children’s access to care**, due to [lower payments](#) to children’s hospitals and pediatric providers.
- **Fewer older adults able to stay in their homes and communities**, as programs [reduce or eliminate](#) home and community-based services and supports.
- **Decreased access to mental health and substance use disorder treatment**, at the same time that opioid overdoses skyrocket across the country, due to [cuts to program funding](#). Medicaid is the largest payer for mental health care, and one-third of those in the expansion population have mental health and substance use disorder needs.
- **Longer waitlists for people with intellectual and developmental disabilities**, as crucial home and community-based services [may be eliminated](#).

Support for strengthening Medicaid is a bipartisan issue. According to [recent polling](#), 4 in 5 voters (80%) believe increasing funding for Medicaid during the COVID-19 crisis should be a priority for Congress, including a bipartisan majority of Democrats (92%) and Republicans (68%). Voters also want to see the new Administration take action on this critical issue, with 75% saying increasing Medicaid funding should be a priority for the Biden-Harris Administration in its first 100 days.

Thank you for your efforts thus far to address public health during this challenging time. The Modern Medicaid Alliance is eager to work with the new Congress and new Administration to ensure that, together, we overcome the COVID-19 crisis.
